Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$25.00. You may register your dog online at <http://nasda.dog/registration/>.

Awards:

Awards will be self-serve, and scores will be available at the end of each class. Ribbons are awarded for qualifying score, High in Class and New title ribbons. If you are close to finishing up a Level III title or higher, or a versatility title please contact Connie ASAP!

Venue:

Exhibitors will be crating their dogs in or near their vehicles. **Canine Training Adventures NASDA Club** reserves the right to remove any individual for any reason from the premises. No refunds will be issued.

No Camping at this venue.

Trial Format:

• **Check in at 8:30 am, briefing at 9:00, trial starts at 9:15 am. Start time subject to change.**

• All trials for each class will run back-to-back. Teams will walk from the completion of Trial 1 to the start line of Trial 2. Exhibitors with multiple dogs in the same class, we will do our best to run other dogs in between yours.

Note: Adding classes day of trial is allowed if space allows. However, this MUST be done prior to the class starting at any level. For example, I want to add my dog to UL II, but they just started UL I. I will not be able to do this. Adding a class must be done prior to the class starting at any level.

Notice to Exhibitors:

- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- If the trial is cancelled by the club for any reason, all exhibitors will be notified via email and entry fees refunded in 30 days.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- Refunds will be mailed 7 days after the event
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage

in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.

- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- BIS may compete in protective gear and may run at the end of each class.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$25 fee for any returned check or payment. Checks must be made payable to **Canine Training Adventures NASDA Club or CTA**.
- **Canine Training Adventures NASDA Club** reserves the right to refuse any entry without cause or explanation.
